MEMORANDUM OF UNDERSTANDING BETWEEN

(University/Institution/Think Tank/NGO/Multilateral Agency) AND

Rajiv Gandhi Centre of Advanced Technology (R-CAT)

(Rajasthan, India)



- I. The broad purpose of cooperation between (University/Institution/Think Tank/ NGO/Multilateral Agency), and R-CAT and are as follows:
 - To promote interest in the teaching, training, learning, research, innovation, and competency development activities of the respective institutions.
 - To be united by common objectives, and to establish channels for collaboration for joint initiatives, projects, and campaigns through developing synergy in communications and cooperation.
- II. To achieve these broad goals, (University/Institution/Think Tank/NGO/Multilateral Agency), and R-CAT and will do the following insofar as the means of each allow:
 - To carry out joint initiatives to support students, alumni, faculty members and staff
 - Promote institutional exchanges by inviting faculty and staff/trainers/instructors of the partner institution(s) to participate in a variety of teaching/training, outreach, innovation, and research activities for academic and professional development.
 - To receive students of the partner institution(s) for a particular period of training, live projects and/or internship.
 - Organize Training Programmes, short courses, events, meetings, and webinars on issues of common national/global concerns.
 - Develop/Create institutional tasks forces and committees on important issues related to areas of technology education, innovation, application, and democratization, by having experts/members from both partners and their respective networks/ecosystems to carryout research/survey/studies and publish joint reports thereof.
- III. The parties hereto can appoint representatives to carry out the planning of discussions, partnerships, and other programs.
- IV. The present MEMORANDUM OF UNDERSTANDING (MoU) shall be reviewed upon written request by either party at any given time. Modifications are executed and approved through the exchange of letters, which then become addenda to this memorandum.
- V. Pending approval by regulatory authorities, this agreement shall commence on the day that it is signed on behalf of......(University/Institution/Think Tank/NGO/Multilateral Agency), and R-CAT and shall remain in effect for a period of

three (3) years, during which it may be terminated by either institution at any time by giving advance written notice. Such termination by one institution shall be effected by giving the other institution at least one month (30 Days) advance written notice of its intention to terminate. Termination shall be without any penalty to either party. If this agreement is terminated, neither (University/Institution/Think Tank/NGO/Multilateral Agency), nor R-CAT shall be liable to the other for any monetary or any other losses that may result because of this termination.

VI. The signing parties of MOU realize that the above-mentioned areas of activity signal only the beginning of mutual cooperative efforts. As the relationship between the two institutions develops and strengthens, the scope of this agreement may be expanded to cover other areas of cooperation.

VII. The MOU empowers and obliges only the signing institutions not individual persons.

VIII. Financials and other terms and conditions for any specific project carried out in furtherance of this MoU shall be decided mutually and shall be signed through a different agreement / MoU.
