1. Objective:

The objective of the scheme is to provide financial assistance to students, who are domicile of Rajasthan and are willing to study at Rajasthan Centre of Advanced Technology (R-CAT) in order to enable them to complete their job-oriented training programs in R-CAT, leading to global certifications.

2. Scope:

These scholarships are available for the courses offered at R-CAT only and are awarded by the Government of Rajasthan to applicants who are residents of the state and fulfil the necessary criteria as mentioned in these Regulations.

3. Conditions of Eligibility:

- I. The scholarships are open to nationals of India who are domicile of the State of Rajasthan. He/ she must possess Jaanadhar card.
- II. These scholarships will be given for the study of all recognised certification programmes pursued by the students in R-CAT only.
- III. The applicant should be more than 18 years of age.

IV. Applicants who will get selected through Selection Process (Category – I), should:

a. Pursuing any degree/diploma from a recognized college/university and has scored a minimum 60% marks* or equitant CGPA/SGPA/OGPA/grade in last semester/yearly exam of pursuing course, provided that: -

For Ph.D. Scholars minimum 60% marks in last degree/ diploma examination.

Completed any degree/diploma from a recognized college / university and has scored a minimum 60% marks* or equitant CGPA/SGPA/OGPA/grade in last semester/yearly exam of completed course, provided that:-

Duration from date of declaration of last result and last date of registration for Quiz-A-Thon exam is not more than one year.

*If the fact of obtaining 60% or higher marks can be established by marks obtained mentioned in mark sheet or by any other means, that fact should be considered in decision making.

Note: - in case candidate is perusing first Semester/Year of degree/diploma than minimum 60% marks in last degree/diploma examination shall be considered. Provided that Last degree/diploma result declaration date must not be prior to 2 years from last date of registration for Quiz-A-Thon exam.

4. Selection of Candidates:

I. Category – I

- a. R-CAT/RISL/DoIT&C shall announce and conduct a series of Selection Test/ Competitive Exam/ Quiz-A-Thon for upto 100% scholarship of course fee selected through this process.
- b. Students who are pursuing any regular technology degree or diploma from a state-recognized college or university and who meet the other qualifying requirements can register on the R-CAT portal in order to take part in this process.
- c. List of candidates selected through the Selection process shall be announced at the end of the process. Thereafter, the selected candidate would follow the subsequent registration and counselling process as detailed above.
- d. Candidate selected through Selection Test/ Competitive Exam/ Quiz-A-thon will get the opportunity for training and certification with leading technology giants partnered with R-CAT.

II. Category – II

- a. Govt. Departments/PSUs/Organizations/Boards/Associations/ Academic Institutions shall be communicated to refer eligible candidates as per the selection criteria.
- b. Further the administrative department of the concerned organization will inform ED, R-CAT about the nomination.
- c. Once the list of selected candidates is finalized by the committee, the same shall be conveyed to respective colleges, organizations, departments, and candidates as well.
- d. Further, candidates would require to register on the R-CAT portal along with all relevant documents to be uploaded on the portal.
- e. After the verification of required documents, candidates would be referred to different OEM's / TSP's as per the courses offered by them and the choice of the candidate or recommendation by the nominated authority.
- f. OEM's / TSP's shall organize the general counselling session with the candidates before enrolling them to training batches.
- g. IIT Jodhpur, IIM Udaipur, IIIT Kota, MNIT Jaipur, and Government Colleges of the state may nominate their 20 students in each semester for courses offered on scholarship by R-CAT. The selection criteria for these students shall be on merit basis by the concerned institute.
- h. The number of nominations shall not exceed 20% of the total scholarship quota (currently 2200 students per financial year). Further in case of over subscription, selection of candidates shall be finalized by a committee under chairmanship of Executive Director on the basis of merit/marks and other criteria seems suitable.

Based on the percentile an applicant got on the scholarship test, the value of the scholarship will be determined—

S. No.	Percentile obtained in the selection process	Value of Scholarship
1	More than and equal to 90 percentiles	100% of the course fee for the candidate's preferred course
2	More than and equal to 80 percentiles to 89 percentiles	85% of the course fee for the candidate's preferred course
3	More than and equal to 70 percentiles and up to 79 percentiles	70% of the course fee for the candidate's preferred course
4	More than and equal to 60 percentiles and up to 69 percentiles	50% of the course fee for the candidate's preferred course
5	Less than 60 percentiles	No Scholarship

Specially abled applicants will be entitled for 100% scholarship (one candidate for only one course and for one time) for R-CAT courses on obtaining 60% percentile in “Quiz-A-Thon”.

6. Duration, Renewal and types of Scholarships:

- I. Any student who has availed the scholarship for one of the certification programs, shall not be eligible for any other scholarship in same FY, further any student who clears the Global Certification Examination may avail one more Scholarship.
- II. Scholarship offered by R-CAT would be broadly divided into two types
 - a. **100% Sponsoring:** In this category, RCAT would sponsor 100% tuition fees of selected/nominated candidate (As per the requirement, RCAT and line department may nominate Government employees, entrepreneurs, students and working professionals etc.)
 - b. **Subsidized course fee:** To cater all the targeted beneficiaries at large, RCAT would offer different type of subsidized course fee for beneficiaries of all categories. Subsidized course fee will range from 50% to 100% discount.

7. General Terms and Condition

- a. Sponsoring / scholarship covers training and certification fee only, no other fee or cost e.g. lodging & boarding, training & learning materials, etc. shall be covered under the offered Sponsoring/scholarship
- b. It will be mandatory for the candidate to produce all the required documents to avail the benefits
- c. Once the candidate is eligible on the basis the categories listed above, the candidate shall have to undergo through counseling, document verification, etc. and then he/she shall have to

- d. The decision of the institute shall be final and cannot be contested on all matters of scholarships and concessions at Rajasthan Center of Advance Technology, Jaipur Campus. The institute has the right to discontinue the scholarship at any time if the student is involved in any disciplinary case.
- e. Scholarship will be given to candidates on first come first serve basis (Category – II) and Score in the Quiz-A-Thon test (Category – I) will be the parameter for shortlisting among eligible candidates. Top scorers will be given priority.
- f. Any exclusions must be brought up and approved by ED, R-CAT.

Procedure for Applying

The eligible and interested candidates need to submit their application form along with the requisite documents that substantiate their eligibility criteria online, through the R-CAT website.
